2020 AGM - President's Report

On behalf of the Management Committee of the Cooroy Veteran's Golf Club I wish to extend our sincere appreciation to all of our Members for the tremendous support and encouragement offered to us during the past year. Without this support the VETS would not survive.

This year has been a major challenge for us all, at a personal and golf level, as a result of the upheaval resulting from the Covid 19 health crisis. We have come through it all though and I wish to thank all Members for their resolve in these challenging times.

I take this opportunity to thank the hard working members of your Management Committee as without their high level of energy, commitment, support and good humour; we would not have been able to achieve what we have this year. Special thanks to our Captain Grant, Vice Captain Jim, Host Day Captain Dave and Secretary/Treasurer Rod for the great effort they have put in this year.

I would also like to acknowledge and thank the many volunteers from the VETS who have assisted us and the Cooroy Golf Club throughout the year - in particular the regulars who turn up on clean up days and host days. The improvements to the course are a testament to their efforts.

A special thanks also to CGC President Greg Michael and his team on the Cooroy Golf Club Management Committee and most importantly to Wayne, Todd and the CGC staff who keep the course in great condition and who look after us before and after games.


A big thanks to all of our sponsors – external and Members - as without their funding and contributions we would not have been able to provide the level of support to our Members and players that we have throughout the year.

Given the impact from the Covid 19 restrictions, the past year has been hugely successful on many fronts, game wise and financially, Grant and Rod will provide you more detail on this in their reports. Unfortunately the restrictions put an end to our Host Day plans and we look forward to resuming these important events in the coming year.

Our membership sits at 139 (including 27 new Members) plus 6 restricted members from the Ladies. We have played 3381 rounds of golf - 3063 Wednesdays and 318 Host Days - with Wednesday fields averaging 83, which is an excellent outcome considering the 2 month shut down.

As I mentioned before, we have done well financially this year achieving a cash balance of \$13,311.

This year we have paid \$46,458 to the Cooroy Golf Club through purchases of goods,



prizes and services on game days. Since 2012 we have paid the Cooroy Golf Club a total of \$390,772 for these purchases, which is a great effort.

On the Funding Initiatives front, this year we have donated \$7,737 to the CGC to support the purchase of a Stihl HTA battery operated pole pruner and a Toro Workman all purpose utility, which is due to arrive late this month.

These items of equipment will provide great support to the grounds staff and our volunteers as they continue work on course improvements.

Our Weekly Newsletter continues with good feedback from Members and we plan to continue providing Member Updates throughout the year. On the subject of feedback, as a Committee we look forward to constructive feedback to keep us all on track as we all just want to get out there and enjoy our golf.

Once again Grant has been very innovative in the development and management of our events with great support from Jim and from a social perspective we have seen the reemergence of our sausage sizzles and Marty's Hut burger days. Due to Covid restrictions, we are planning an event at Marty's Hut for our Xmas function for the last playing day of this year.

We have donated \$868.90 to Prostate Cancer Foundation of Australia and expect to donate a similar amount through this year's fundraiser in November.

Once again, thank you for your support and let's look forward to a great year in 2021.




2020 AGM - Captain's Report

Cooroy Veterans' Golf Club 2020 AGM - Treasurers Report



Invariably we do better than break even allowing us to put aside funds surplus to our day to day operational needs. These surplus funds are held in the *Sinking Fund* and become available for investment in *Funding Initiatives* with *Cooroy Golf Club* and/or donation to a charity considered worthwhile.






