2022 AGM - President's Report

On behalf of the Management Committee of the Cooroy Veteran's Golf Club I wish to thank all our members for the excellent support and encouragement provided to us during this past year. It is the Members who make this such a great club.

During 2021/22 we have again completed a successful year, golfing wise and financially. The reports from Secretary/Treasurer Rod and Captain Grant will provide greater detail of our achievements over the past 12 months. Unfortunately, the impact of the weather we experienced at the beginning of this year, with the course closed for a long period, has understandably diminished our financial position.

I wish to take the opportunity to thank the members of your Management Committee for the hard work, commitment, high level of support and great fellowship that they have provided over the past 12 months. There is great commitment from all involved. Special thanks again to Rod, Grant, Jim, and Dave for their organising efforts that have allowed us all to have a great golfing and club experience.

I would also like to acknowledge and thank the many volunteers from the Vets who have assisted us and the Cooroy Golf Club throughout the year, in particular the regulars who turn up on Tuesdays and host days. Thanks also to CGC President Terri Cairns and her team on the Management Committee and of course Warren, Wayne, and all the CGC staff. A special mention for Course Superintendent Warren who has worked exceptionally hard under very trying circumstances to maintain our course to an exceptional level. Well done Warren and thank you.

A big thanks to all of our sponsors, both external and members, as without their level of support we could not provide the experience we have been able to, to our members and visiting players. We are pleased that we have been able to continue our Marty's Hut Day experiences as this is one of the ways in which we can pass on our thanks and appreciation to you all.

Our membership sits at 157 overall, with 16 new Members joining us this year. We have continued with our Host Days, and this has made a solid contribution to our financial position. Our aim is to make our course an attractive place to visit on these days (attractive prizes, enjoyable yet challenging course, friendly atmosphere), something we always achieve. With our Wednesday competitions the average field reached an impressive 97, with quite a few 100+ days.

We have done well financially and have finished off with a cash balance of \$12,374. Rod's report will provide you with greater detail. This has enabled us to donate \$15,000 towards the Club's purchase of a near new Toro Greens Mower. Discussions continue with the Club on how we might provide further project support into next year, as that is our

aim. We have paid a total of \$65,375 to the Club this year through the purchase of goods, prizes, and services on game days. In the 10 years to 30/9/2022 our total purchases from the Club have reached \$497,190. In addition, we have also funded project initiatives to the tune of \$56,321, giving a total of \$553,511. Thanks again to you, our members, for the support in enabling us to reach this position.

Our Weekly Newsletter is an important tool for keeping Members informed of our activities and your positive feedback on this initiative will ensure its continuation. All constructive feedback is welcomed as this allows us to stay on track in providing the support you require.

Once again, thanks to you all as we look forward to a successful 2022/2023.




2022 AGM - Captain's Report




NOTES to 2022 FINANCIAL REPORTS:
