Secret Meetings

• There has been a lot said about purported secret meetings. There have been **no 'secret meetings'** making decisions about running the club.

Members of the various committees decide when and where it is most practical for them to meet. The clubhouse is not always the most practical place. The primary purpose of Executive Committee meetings earlier this year was a general catch up after an extended holiday break and to brief the new secretary, Tina Thomas.

Constitution Rewrite

- The rules of the club (Constitution) have undergone many revisions since the club's establishment in 1935. The current Constitution is not fit for purpose, an assessment confirmed by external experts, and needs a rewrite to recognise changes in laws, adopt modern best practices, make the language clearer, and ensure proper protections for members and the club.
- With financial support from Golf Australia, the club has engaged local governance consultants CPR Group to develop a new constitution for Cooroy Golf Club. CPR Group is Australia's leading sports governance, planning and community development provider and has been involved in Constitution rewrites for 100's of clubs Australia wide including clubs on the sunshine coast.
- The learnings and experience from each rewrite exercise improve the CPR process for the next constitution rewrite.
 - Based on CPR Group experience the process follows a standard timetable with defined steps to ensure the process reaches a successful outcome, but times allowed for each step can be adapted to suit club circumstances. The member consultation step is crucial. It takes as long as needed to ensure member views are considered in reaching an outcome acceptable to members. The club will make a draft version of the constitution rewrite available to members for review with covering notes explaining the changes so members can provide feedback. CPR Group will facilitate the member review process not the management committee.
- CPR have completed a first draft of the Constitution, but we have paused the process because of the current disruptions.
- A successful rewrite is critical for the future operations of the club. Using external experts and following a proven process will ensure a successful outcome, including protections for members and the club.

		•	As the Constitution provides that the Vice President shall assist with and carry out the duties of the President as and when required, it makes sense to invite the Vice President to join the Executive Committee. This has traditionally been the approach for quite practical reasons. If the VP needs to assist with and step into the President role as and when needed, then the VP clearly needs to have the same level of understanding of what is going on at the club.
		•	The charter put forward to the management committee aimed to provide clarity around the role and responsibilities of the Executive Committee but recognised that each of our club sub committees also need a charter.
		•	As a result of discussions with CPR Group about the rewrite of the Constitution, the management committee reviewed and reversed its earlier decision to approve the charter as it will be addressed in the rewrite.

As you can see the management committee did not reject providing access to the minutes of management committee meetings and offered options to facilitate the request. Jeff McDonald then requested access to the January/February minutes. The club secretary organised a date and time to meet at the club house, but Mr McDonald cancelled without rescheduling.

		■ The management committee decided it needed more information and to consult with GemLife particularly in view of the proposed location and as implementation of a water management plan is part of the GemLife deliverables to address water security. Further investigations and discussions with GemLife validated the decision to seek more information.
		 The project became less urgent once it rained so it was paused and moved down the list of priorities, saving a cost outlay with NO GUARANTEE of a result.
10	The loss of our manager after 20 years of service – not allowing our manager to do his job without micromanaging. With other staff suffering the same treatment. 		On several occasions the management committee issued 'statements of support' at Wayne's request. The need to do this often arose from derogatory comments made about Wayne's performance by members now raising grievances and associated with the recent publishing of false and misleading information. The club manager has the authority to present a case for a variation in staff levels for consideration by the management committee. The committee did not prevent Wayne from doing so. The accusation 'with other staff suffering the same treatment' is unsubstantiated and emphatically rejected.
11	The lack of foresight in not finishing the bridge upgrade to hole 7/15 and the decision to spend an extra \$15,000 on the said bridges.	 To quote from the management committee minutes of 21/2/2023 under the heading Outstanding Items "Bridge over Hole 15 has been put on hold until GemLife outcome". Those present at meeting included Keith Harkins (President), Jeff McDonald (Secretary), and Grathan Leatherbarrow (Greens Director). The current management committee inherited this decision. The allegation about the decision to spend an extra \$15,000 on the said bridges is unsubstantiated and misinformation. The subcommittee formed at the time to address the replacement and upgrade of bridges exercised reasonable care and diligence in considering the most suitable options and recommended accordingly.
12	Constitution – Nov SGM, were put on notice about unconstitutional proceedings, Mr Rod Booth ordered that the meeting proceed, and it did – the club is now open to investigation from Department of Fair Trading. 		•	The club legal advisor was present at the SGM and advised that the assertions made by Pat Allen were not relevant to the business of the SGM and that the meeting should be allowed proceed to a vote after Mr Allen was heard.
		•	Rod Booth acted properly in passing this advice to Peter Piggott , the chair of the meeting, to direct accordingly.
13	Continual interference with running of the golf program. Outside their roles.	•	Clause 10.4 of the Constitution provides the management committee with the power to appoint from members of the Club the following sub committees: Finance, Men's Golf, Women's Golf, House, Greens, and others as considered necessary.
			The Constitution provides that such sub committees shall perform their function within the policy and in accordance with the direction given to it by the management committee.
			The management committee is acting within its authority by providing direction and advice to the Men's and Women' sub committees and other sub committees.
