PAYMENT OF FEES

All fees are inclusive of GST. Once paid, fees are not refundable. Levies (L) are defined as: Affiliation Fees, GolfLink Fee, and Insurance. Members may elect to pay annual fees by one of the following methods unless otherwise stated above.

- 1. By *payment in full* before the first day of membership year.
- 2. By *two instalments.* Members electing to pay by this option must pay the first half year instalment plus a \$20.00 administration fee plus Levies, and any Supplementary Fees.
- 3. By a *monthly direct debit instalment plan* provided through Ezidebit direct debit facility service usage fees apply. Members electing to pay by this option must pay a \$20.00 administration fee plus Levies and any Supplementary Fees upfront in first instalment.

OTHER:

- 1. *PAYP playing fees* (a) Competition Fee + \$20 (b) Member Social Round \$20 (effective from 1st July 2024)
- 2. *Temporary membership*, limited to a period not exceeding three consecutive months, is available on application to the Club Operations Manager.
- 3. *Family account billing* allowing subscriptions and supplementary charges for individual family memberships to be grouped and invoiced under one 'Primary Account' is available on request.
